**Minutes of the 90<sup>th</sup> Annual Session  
Friday Morning Business Meeting  
Friday, June 10, 2016**

*Grand Officers were seated informally in the East. Grand Marshal, Sarah Mobroten, presented the Flag of our Country – the Pledge of Allegiance was said. Grand Chaplain, Linda Bican attended at the altar and offered a prayer.*

**Rosemary Guntzel #39:** Good morning everyone and welcome to the 90<sup>th</sup> Annual Session of the Grand Guardian Council of Minnesota. We know that your presence here this weekend means that each of you are committed in working with our Daughters. All our adults are willing to give of their time, love and support in helping to guide our young ladies. Even though we have seen Bethel's suffer the distress of discord and a lack of inconsistency we are all striving to help each other and are committed to see our Bethel's grow. We will be hearing from adults and committee members on how well we are doing. We would like to thank everyone for traveling to Alexandria to share this time together. This year brings to a close 89 years of Minnesota Job's Daughters.

**Rosemary Guntzel #39:** Carol Gillett please give a partial report of the Credential Committee.

**Carol Gillett #32:** This is a partial report of the Credential Committee. As of 9:15 a.m. Friday, June 10, 2016 there are 15 Bethels represented with delegates in attendance. There are 34 voting members from at least 10 different Bethels.

**Rosemary Guntzel #39:** A quorum for the transaction of business of this Grand Guardian Council consists of at least 15 voting members, of which at least 10 shall be representing different active Bethels. There being a sufficient number of voting members representing a sufficient number of Bethel's to constitute a quorum, I proclaim the 90<sup>th</sup> Annual Session of the Grand Guardian Council of Minnesota, Job's Daughters International, open for the transaction of business which may legally and properly come before it. Grand Marshal, you will make the proclamation.

Only voting delegates are privileged to address this body. Non-voting delegates may speak only if invited to do so by the Grand Guardian or other presiding officer.

When addressing the assembly, please use one of the microphones. Give your name and Bethel # before making any remarks.

Any motions that you will put before this body, must be done in triplicate. There are forms available at the Jurisprudence desk and the Grand Secretary's desk.

**Rosemary Guntzel #39:** All reports that are read at this session will be handled in the following manner. I will say, "If there is no objection, this report is received. Hearing none, this report is received and will be printed in the Proceedings."

**Alumni, Jeanne Whetstone**

To Grand Guardian Rosie, Assoc. Grand Guardian Ken and the Grand Guardian Council

This year the Alumni Committee has continued to update the Alumni database, answer questions and send out information. We decided not to have a major function like we did in the past but work more on the database. We are hoping that Bethels will continue to send us the names of their Majority Members so that we can add them to the database.

**Diane Ritchie #18:** The duties of this committee is to meet and have an event every year. Is this not done?

**Jeanne Whetstone #1:** The last event we did not have a lot of people so we decided not to have an event and work on the database.

**Diane Ritchie #18:** If we decided to continue to have this event, then it would continue to grow. You will never find a date that works for everyone.

**Grand Secretary, Clare Haugen**

Grand Guardian Rosemary, Associate Grand Guardian Ken, and Members of the Grand Guardian Council.

This past year of 2015-2016 has been interesting. It all started with the receipt of the 2013-2014 information list for the Annual Reports. Upon my returning the list with the comment "I was sent the wrong year's list," I was informed that, "no I wasn't," as a new person had been hired to take care of all the Annual Reports and when she was asked a number of times how she was doing, she'd answer, "just fine." At some point it became known that she had not done anything so thus the list was returned to me to be done over. Needless to say, I was not thrilled with having to do two year's work instead of one all at once. After about 12 hours on the computer I was finally back to where I was now starting on the 2014-2015 list.

The entire process took much time. Dual members also take additional time to make sure they are documented everywhere they should be.

Several Bethels did end up paying the Late Fee as they had issues to be resolved.

The largest Bethel in Minnesota continues to be Bethel #48, Anoka, with 26 members, an increase of four members. In second place is Bethel #9, Mankato, with 22 members, an increase of four members. There is a tie for third place between Bethel #28, Duluth, and Bethel #76, White Bear Lake, each with 18 members. Bethel #28 gained 2 members and lost three. Bethel #76 gained 4 members and lost three.

The 2015 Annual Report showed 14 Active Bethels. It also included two Closed Bethels, one of which, I am tracking the remaining members to Majority and the other was a former member of a Bethel who had been suspended for non-payment of dues and now paid her dues to Majority.

These Bethels had 192 members at the beginning of 2015. We Initiated and Affiliated 31 new members for a total of 223 and lost 36 due to Majority, Demit, Resigned, or Suspended. This leaves us with 187 Active Members with 14 Active Bethels at the end of 2015. This number includes 8 instate Dual Members so the actual number of members is 179.

The Annual Report was filed on time with the Supreme Guardian Council. Thanks to all the Bethels who do get it done and to me on time.

The Tax Form 990 was prepared by *Messerli and Schadow* and filed electronically with the IRS before the deadline. All the Bethels filed their Form 990-N(e-Postcard) prior to the deadline. A copy of each receipt was also submitted to the SGC with the Annual Report.

My Books have been audited by the Finance Committee and found to be in order. I filed all the beginning of the year reports with the SGC. The Corporation was registered for the new year and Minnesota State Sales Tax was paid and the report was filed. The Minnesota Charities yearly re-registration was paid.

Those Bethels who pay their invoices within 30 days are most appreciated.

In May I hosted the Annual Meeting of the Finance Committee, Grand Treasurer, Grand Guardian, Associate Grand Guardian, and Vice Grand Guardian.

M'Lyse, thanks as always for answers to my computer questions.

Bob, thanks for your continued support.

To the Members of the Grand Guardian Council, thank you for your continued support and the confidence you have placed in me. I continue to love the challenge.

I received the DoRP box from Pam Leech after the 2015 Grand Guardian Council Session in June. I knew right away I needed more information. Pam left some beautiful award certificates in the box, so I used one of them. Actually I prepared two certificates in case something happened to the first one. They were signed by the Grand Guardian and the Associate Grand Guardian. I found an inexpensive frame to use during the ceremony. It kept the certificate in good condition. Many of the dollar stores have nice frames for a (you guessed it) dollar.

I also bought an imitation white rose and tied it with purple and white ribbons to give to Lisa. (There is some ribbon left in the box.)

The ceremony went perfectly. Lisa was truly surprised and received a standing ovation. Thank you Kristen and Kellie!

Finally, I want to thank the GG Council for asking me and my fellow committee members to chair this committee. It was great to read about Lisa and the way her friends admire her. I know that she will continue giving of her time and energy to Job's Daughters International. She is very special.

## **Marketing, Alida Black**

GG Rosie, AGG Ken, Members of the GGC,

What an exciting and busy year it has been in the promotion department of MNJD.

I started the year off by having a phone conversation with most of the BG's across the state. Questions consisted of how many members, adults and JD2Bs each Bethel currently had, if they had a Director of Promotion, what and how much marketing materials they had, what they currently were doing for promotion and if they had an established prospect list. After these phone calls I had no questions as to how we got into this membership funk. Most Bethels did not have an active JD2B program or a written, up to date prospect list, they had little to no marketing materials and most had no Director of Promotion which put the job back on the already over worked BG's. Some of whom were having a hard enough time figuring out their own job, let alone the large task of how to promote the Bethel and with little to no help from the state. It was clear that there was a lot of work to do.

The first step was to start changing our strategy to marketing more than promoting. We needed to move beyond just parades and talking to friends. The reality is that we are not just some small organization for girls to have sleepovers and learn how to memorize, however, that is how we were presenting ourselves to the public. We are an International organization that has a long history of giving young ladies the skills to be strong, independent future leaders. We needed to look the part. Each Bethel was given the opportunity to receive a professional display board, banner, business cards, and crayons to help with a coloring contest. In order to receive the materials, they would need to have 3 events planned in the first 6 months of the year where they could use the new materials. Of the then 14 Bethels, 9 Bethels participated and received the materials, 2 Bethels did not need the materials and the last 3 did not give reasons as to why they did not participate.

In November we set up a marketing table at the Zuhrah Shrine Circus. A big thank you to Gayle and Brad Johnson for coming to us with the opportunity. A HUGE thank you to Jackie Benn, Miss MNJD Marilyn and AGG Ken for working the table. Marilyn came prepared with her cape and crown and took hundreds of pictures with little girls as "the princess." She did an amazing job marketing our order. An activity sheet was made for the program and glow bracelets were handed out.

In February we held our 1<sup>st</sup> ever Jobie Jamboree. Amy brought up the idea of an all-night event maybe 2 years ago so it was great to see the idea become a reality. Before we get into the details of the event let me tell you a little story. I called my dad's favorite restaurant the other day to make reservations for his birthday. The nice lady on the other line asked "for what day?" I said "Well we are thinking it will be either Saturday or Sunday." "Um, ok, What time?" "Well somewhere between 2:00 in the afternoon and 8:00 in the evening." "And for how many people?" I told her there would be between 5 and 40. Can you believe that she had the nerve to get irritated with me? This is exactly what it was like dealing with the registration for this event. Not sure why we bothered with a registration deadline when only 2 Bethel registered by that date. As I started making phone calls to the BG's to see if anyone was coming I was met with irritation and excuses. Meeting deadlines is one of those lifelong skills that you face on a daily bases and we are failing miserably at teaching that skill to our Daughters. I am fair warning everyone now that there will be a substantial per person late fee attached to Jamboree registration this year. When registration and check-in were complete we had 41 members, 22 prospects, 18 CAV adult chaperones, 10 adults who were not chaperones and 2 non CAV adults for a total of 94 people. We started off with a mock meeting done by the GB. They did a marvelous job! Thank you very much to Kori Hennebry for making sure all the spots were filled and for doing a beautiful job presiding on your 18<sup>th</sup> birthday. Then we went next door to Shauna's Dance Studio where the girls learned 3 different short dances. Shauna's Dance Studio did a great job and they did the classes at no charge. After that we had a prize drawing where every girl was able to receive a prize. 8 prizes were donated by Sarah Mobroten, 27 by Linda Bican and 36 by myself. Prizes will be gladly excepted for the next Jamboree between now and November. Sarah was also able to get us enough beanie babies from the Shriners Hospital for every girl to leave with one of those as well. Then we were off to the Chaska Community Center where the girls were able to go swimming, ice skating, play basketball, volleyball, racket ball and walley ball. From 2:00am – 4:00am Shawn Torrance had karaoke set up for the girls which he did at no cost to us. By 4:30am we were heading back to the Savage Masonic Center where MNRV Lodge #6 and Lebanon Lodge #346 had breakfast waiting for us that they served with a smile. They also paid for all the food and beverages that they served. We are so grateful for their support. The girls signed thank you cards and formal thank you letters went out to the Lodges, the CCC, Shauna's Dance Studio and Shawn Torrance. Thanks to many people's generosity the only costs we had for this event were for snacks, the rental of the community center and the folders that went out to all the prospects. Total cost was \$1,105.76. Total money paid for registration was \$950.00. Which means that only \$155.76 needed to come out of the marketing budget for this event.

Other things marketing did throughout the year included helping with the state wide Initiation, teaching 2 classes at JD You, and attending multiple meetings for the Grand Lodge membership committee with AGG Ken.

This year we came a long way but there is an even longer way to go. There are a few things everyone can do to help us get back to where we need to be. This is not a competition for membership in each Bethel but a partnership across the state. We need to be doing what is best for each girl and if that means that they are closer to another Bethel please pass on that prospects information. You can maybe get them to join but they will not stick around if they have a long drive for every meeting and event. If you get a prospects information passed onto you please, please, please FOLLOW UP on it!!! We should be assuming that every single prospects wants to join our Organization and be treating them and their family accordingly. If it takes you 2 or 3 weeks to follow up with someone that does not make them feel important or valued!

Having enough CAV adults is still a struggle. We need to stop viewing it as a terrible thing and use it to our advantage. In marketing it is all about the presentation. Instead of telling someone they *have* to sit through an all-day class, while rolling your eyes, you are not going to get very many takers. If you tell them they *get* to take a class that will help them understand our Organization and work with our Daughters better, while smiling, they will feel important and the class feels more valuable to them. Although it may not feel like it at times it is a very good program for our organization, as a parent I would be way more likely to let me child join and be an active part of an organization that takes the time to train and check all of their volunteers.

To the girls in the room, you have many adults in your Bethels and around the state that are working overtime to keep the Bethels running the way they should and help you through your time in Job's Daughters. PLEASE tell them thank you every once in a while, they are doing the best they can and your appreciation for that would go a long way.

I was very very impressed with our Daughter leadership this year. Marilyn Benn worked marketing events, gave speeches, made a new brochure and did a great job on social media. Kori Hennebry also helped marketing this year with all she did for the Jobie Jamboree and the state wide initiation. You both are an amazing example for the rest of the state!

It doesn't happen very often that you have multiple committees full of multiple people all on the same page, on board with the same plan, working toward the same goal, but that is exactly what happen this year. Thank you Joanie for working on the finance side of marketing and talking through a few of our crazy plans.

GG Rosie and AGG Ken we are so grateful to you both for being open minded and supportive of the direction that marketing took this year. Thank you very much for all that you do for the MN Job's Daughters.

We are very grateful for the appointment to the Marketing Committee this year and we are excited to see where the future of marketing goes for Minnesota Job's Daughters.

To build off the momentum of last year we need to look further into the future than just 1 year. We need to be continuously looking ahead to our future and always be planning 35 years out. I feel like we have a good start to that right now and since it is always hard to come into a book at chapter 10 I feel it is important to walk you through how we got to this point in the planning process and where we would like to go moving forward.

It started with many many hours of research, phone calls and emails which lead me to a website called the MN Council of NonProfits which then lead me to contacting several different marketing agencies before I found one that was not only the right fit for us but was willing to take a look at our organization and be honest about what they found and the right course of action. What this agency told me was that based on our online presence she would not have guessed that we are a youth organization for girl. She also said that the only way to find us from Google was to type in the exact words "Minnesota Job's Daughters" When what we want to be able to do is type in relevant keywords since most people don't know that they are searching for us. That search should bring them to not only our website but all of our social media and each one should be modern and cohesive with each other. The conversation ended with her telling me that she felt this organization is a benefit to our communities and that she is willing to offer some free advice but that an agency would eat up most of our marketing budget with fees alone and we would be better off finding an independent consultant.

Within that time I had a meeting with members of the Grand Line as well as Joanie Peterson as a member of the Finance committee where we discussed many different marketing ideas and we all agreed with the direction it was heading.

After that a phone call was had with Amanda LeBlanc who, I found out recently, is a part of Target's marketing team. She agreed with a lot of the plan and suggested that a rebranding would be highly beneficial to MNJD.

I then contacted the marketing agency to get their opinion on a rebrand and she was enthusiastically in agreeance with that. Her exact words were "A rebrand is definitely needed for your organization. It currently doesn't present as a youth oriented organization and you will put off some people who might be a great fit and potentially their parents. Yes, it will be more money, but if you want to create success for your organization you will have to spend money or continue to languish, in my opinion."

It was now time to find a professional consultant who could work through this process with us. I contacted Tracy Apps, a PGBHQ

from WI who is a designer at cornershop creative and the owner/designer/photographer of tracy@pps design which she has successfully been running since 2001. She has been creating websites since 1996 and is a frontend web developer. So in addition to her having some knowledge about Job's Daughters she has a long list of credentials in this field.

According to Tracy, rebranding can cover a mission statement, business strategy, visual styles, logo, brand colors, fonts, other look and feel elements, photography and video, communication strategy like training and workshop type meetings, recommendations on social networks and the tone of language and subject matter used for each medium and creating brand style guidelines.

Tracy suggested a plan of attack would be to

1. Have an initial meeting to get a better handle on the current situation and see what success looks like to us.
2. Dive into any analytics data that we currently have from the web or social profiles and analyze the results.
3. Review and evaluate existing website, social media links and some other example communication pieces in print and online.
4. Market research of strategies of similar organizations
5. Create a proposal and quote with all phases/options listed out by price.

Which brings us here.

**Joanie Peterson #41:** Thank you Alida, she has done a fabulous job with doing this. I want to inform you all of the direction we are going with the budget. We have a beginning of a 3-5 year plan to get us out of the rut we have been in for years. We consulted with the GGC and Jurisprudence. Every organization is perfectly designed with the results they are getting by Tim Knight. The Grand Guardian Council of Minnesota is perfectly designed to get the results they are getting. The results we are getting is to have barely maintained a membership of about 180 plus over the last several years. Hopefully we recognize that we all need to change. Right now we have 179 daughters, we have been at that for a couple years. It is too early to see if Amendment 10 will have any effect. 50 years ago we had over 6000 Daughters. Membership has fallen, Bethels are closing. We need to recognize that when our membership falls we also lose adults. We will lose our GGC charter when we are down to 70 members. We could have 10 Bethels with 7 members each. We could have 2 Bethels with 35 members each. Supreme does not want to have any more Bethels under Supreme. They have been lowering the numbers for years. Are you ready to try and make a change, ask yourself are you ready to take a risk, take an active party, be a do-er. Please all of you be doers, not sitters. I would consider that our GGC is under reorganization. We don't know how strong we are. We need to be committed, strong and willing. Are you ready to make a change? Are you ready to take a risk? Are you ready to be actively involved with change? To be a do-er, a worker and not a sitter?

### **Jurisprudence, Bobbie Lampi**

Grand Guardian, Associate Grand Guardian and members of the Grand Guardian Council:

The Jurisprudence Committee met this year only for its annual meeting. All other issues that arose during the year were handled by either telephone or email. Grand Guardian Rosemary Guntzel and Vice Grand Guardian Toni Murray joined Diane Ritchie, Beth Bohlmann and Bobbie Lampi for our annual meeting on May 16, 2016, at Anoka Lodge in Anoka. During the meeting, we reviewed the legislation for Grand Session, the election procedure, installation plans, 2016-2017 GGC plans, reports of the Grand Guardian and other business session details.

The Supreme Jurisprudence Committee approved all amendments passed at the 2015 Annual Session of this Grand Guardian Council. The approved amendments were incorporated in the Minnesota Manual and published on the website. We usually do not publish our amendments until after Supreme does theirs, so that we can take care of any pagination problems that might have arisen.

During the year, many members of the Grand Guardian Council consulted the committee on questions of law. The committee made every attempt to provide answers consistent with the laws of the Order, whatever their own personal opinions might have been on the subject in question.

Per the requirement in our bylaws to have one of the Jurisprudence Committee or a representative at the Annual Session of the Grand Bethel, the Jurisprudence Committee was represented by PGG Beth Bohlmann. We thank her for her service during this meeting. Although not attending Grand Bethel, Bobbie met with and Diane was available for a phone conference to help resolve several issues that arose during the weekend.

This year Diane Ritchie has again worked with Bethels to update their guidelines. To date, all Bethels have completed this task. Many thanks to Diane for the hours that she has spent pursuing Bethel leaders to complete this requirement. There have been several inquiries concerning guidelines – their interpretation and process for change.

Specific items that the committee worked on this past year include:

- Completed an update of the Bethel Guardian Council Handbook.

- Reviewed and edited the Miss Minnesota Job's Daughter and Miss Junior Jobie written tests.
- Reviewed and edited the GB Line Officer examination, the GB Guide and Marshal Floor Work examination, the GB Post Installation open book examination.
- Reviewed and edited the application for scholarships.
- Reviewed and edited the Grand Bethel Book of Ceremonies.
- Completed an update of the Minnesota Bethel Bylaws. These will be distributed to each Bethel.
- Amendments to the Manual of Rules and Regulations to be considered at this Annual Session were solicited from the membership of the Grand Guardian Council. Proposed amendments were received by the chairman, reviewed by the committee, and edited as necessary in consultation with the proposers as needed. The amendments were numbered, typed in final form, and distributed by email and mail to the members of the Grand Guardian Council on May 26, 2016.

In closing, the committee would like to thank Grand Guardian Rosemary Guntzel for our appointments. I personally wish to thank PGG Diane Ritchie and PGG Beth Bohlmann for all their assistance and counsel. While the Jurisprudence Committee has a steady amount of work to complete, the committee members share much enjoyment in accomplishing that work.

I would also like to extend my thanks to the webmaster, D Hennebry, for placing the Manual of Rules & Regulations on the web site; and to our Grand Secretary, Clare Haugen, for sending the amendments we approved last year to the Supreme Jurisprudence Committee in a timely manner.

**Bobbie Lampi #11:** We will now consider the proposed amendments to the Manual of Rules and Regulations of this Grand Guardian Council. Please take out the copy of the amendments emailed or mailed to you. If you do not have your amendments with you, a few copies are available on the desk of the Grand Secretary. Additionally, the amendments will be projected on the screen.

I would like to review the procedure we will follow. Following the reading of each amendment, the Jurisprudence Committee will move that the amendment be submitted to the delegates for consideration. As a committee motion, it does not require a second. The committee makes this motion only to expedite the business of the session since the delegates cannot discuss anything until it is put on the floor in the form of a motion. This means that the committee neither approves nor disapproves the amendment; that is the decision of the voting delegates.

The proposer of an amendment or maker of a motion shall have the right to speak first on such amendment or motion. Debate on amendments or motions shall alternate between those "for" and those "against" when there are two sides that desire to be heard.

Amendments must be passed by a two-thirds majority vote. Motions require only a simple majority, that is, more than half. Immediate amendments, that is, those not distributed to delegates before the session, require a unanimous vote of approval for adoption. Such immediate amendments must be submitted in writing and require the signatures of six members representing an equal number of Bethels of this Grand Jurisdiction.

Any amendment passed will automatically amend any other laws pertaining to the same subject. All amendments passed at this session will not become effective until they are approved by the Supreme Jurisprudence Committee, printed in proper form, and distributed by the Grand Secretary.

We will now consider the proposed amendments to the Manual of Rules and Regulations of this Grand Guardian Council.

Diane Ritchie #18: We have updated the Bethel bylaws, cream pages, with the changes from supreme. You will need to have those sign them and seal them and then you can make as many copies as you need.

### **Amendment 1**

**MB-GGC-3.1, Article IV Committees, Section 4 Standing Committees, new G.**

**Action: Adds new Standing Committee for Marketing. If this is adopted, the JD2B, Promotion, and Publicity Committees under Other Committees – Duties would be deleted and that section renumbered.**

#### **Currently Reads:**

**Section 5 Other Committees – Duties (G, I, and J)**

G. JD2B Committee shall:

- (1) Assist the GG in encouraging the use of the JD2B materials in Minnesota Bethels as an aid to membership growth.

(2) Advise and work with the Miss Jr. Jobie in developing new and innovative JD2B materials and programs.

I. Promotional Committee shall:

(1) Assist the GG in promoting the growth of the Order in this Grand Jurisdiction and for the reorganization of, or assistance to, existing Bethels when such need is established. The Chairman may ask a DGG in the area to aid in this work, with the approval of the GG.

J. Publicity Committee shall:

(1) Act under the direction of the GG in preparing and securing publicity in the press and other media for news items concerning activities of JDI.

**Delete above sub-sections G, I, and J of Section 5 and Amend Section 4 by adding new G to read and reletter:**

G. Marketing Committee shall:

- (1) Assist the GG on promoting the growth of the Order in this Grand Jurisdiction and for the re-organization of, or assistance to, existing Bethels when such need is established. The chairman may ask the DGG of the area to aid in this work, with the approval of the GG.
- (2) Assist the GG in planning and implementing events that encourage retention of current members as well as membership growth.
- (3) Oversee all social media accounts and make sure that they are updated regularly with relevant and appropriate content.
- (4) See that efforts are made to educate adults and Daughters around the state on how they can help with the promotion of our Order.
- (5) Assist the GG in setting up speaking engagements for the Miss MNJD within, as well as outside of the Masonic Family.
- (6) Assist the GG in encouraging and supporting the use of the JD2B materials in MN Bethels and work with the Miss Jr. Jobie in developing new and innovative JD2B materials and programs.

**Reason:** It is hard to gain traction in membership when planning for promotion/marketing can only be done one year at a time. A 2-5-year plan would be greatly beneficial to this committee and would need more consistency with committee members to implement that plan. In addition, more time and energy should be spent on this committee making it difficult for only one or two people to do especially if one or both of those people serve on other time consuming committees.

**Carol Gillett #32:** As a member of a committee your duty is to know what it is that committee does. Those girls make a lot of visits and will know the girls and their input would be what their job is on that committee.

**Diane Ritchie #18:** Their duties are defined in the guidelines. In the application itself the questions are asked if the girls are qualified to receive the award. The guidelines are explained right here in the pink pages.

**Rosemary Guntzel #39:** I never approached the girls to be on the committee. The girls have never been on the committee before.

**Diane Ritchie #18:** When you get put on the committee read your duties, if you have questions then call and ask.

**Joanie Peterson #41:** Before you say yes, look at what your duties would be. This is not just to get your name in the directory. If you don't like that duty say no.

**Bobbie Lampi #11:** It is on the floor you cannot withdraw it.

**Diane Ritchie #18:** Just because we adopted that amendment this would still apply. The ones who are already dual members would not be kicked out. It would still apply for both bethels

**Lisa Peterson #19:** I struggle with the nominating bethel. The girl can be really strong in one bethel and then not supporting the other Bethel. They could have unexcused absences in the non nominating Bethel. This is an award that is going above and really exemplifying everything. It should be someone that is strong in all the Bethels they are associated with.

**Diane Ritchie #18:** A Bethel can nominate a daughter without notifying the other Bethel the daughter is involved with. Are we going to change it so that both Bethel's have to nominate her?

**Amy Fitzgerald #85:** Can any Bethel nominate a girl? No they have to be from their Bethel.

**D Hennebry #32:** What if a girl comes to Moorhead and she does have 2 years, but she has only been involved with our Bethel for a year. We would not be able to nominate her because she has not had regular attendance for 2 years. If we were to nominate a girl right away, we would not be able to because she hasn't been there for 2 years.

**Gayle Johnson #18:** How many would not excuse a girl for not being at a meeting for being at college? That should be taken into consideration.

**Sarah Mobroton #88:** The nominating Bethel she had been there for 18 months and had great attendance, her other bethel she had not had such a stellar record. How do we deal with that? How do you determine eligibility for this daughter. Do you go by the nominating Bethel or both Bethel's. In this case it was only looked at the nominating Bethel. There was push back from the other Bethel. This is very vague, does that count as 2 years with her being a member for 18 months.

**Wanda Thompson #16:** Isn't it LOV of the state not just a Bethel. Are you just saying she is LOV of 1 bethel and not of another?

**Diane Ritchie #18:** This was set up for an award for a girl who has does an outstanding job in her Bethel. It is not a statewide award, the Bethel is giving it to her not the state. The Bethel is nominating her for what she has done in her Bethel.

**Joanie Peterson #41:** I have received it a state wide recognition, because we can only give 3 a year. We may have 5 Bethel's who nominate outstanding girls, but only 3 get the award, I would hate to choose who would get it.

**Toni Murray #1:** I should go their whole Job's Daughters life not just that one Bethel. What they have done for the organization.

**Jean Shepersky #61:** The way I read it is that she cannot have an unexcused absence from the nominating Bethel. She has not been a member of that Bethel for 2 years, this does not say she has to be a member of that Bethel for 2 years.

**Bobbie Lampi #11:** You could change so that this says all Bethels. The way to do that is to make an amendment to this proposal.

**Jill Cotton #53:** I move that we change the wording to both Bethels she is a member of.

**Bobbi Lampi #11:** The wording will be: Substitute in the nominating Bethel to in any Bethel in which she is a member.

D. (1) The Bethel(s) of the recipient(s) shall be responsible for the cost of the medallion, sprig of lily of the valley, and certificate. An order form for the medallion is included in the nomination packet. Payment for the medallion is to be returned with the completed nomination forms by the December 1 deadline. Any nominee not selected for the Lily of the Valley Award will have payment returned to the person nominating.

**Reason:** To ensure the recipient does not learn of the nomination, payment for the medallion will be requested when the nomination forms are to be returned to the committee chairman. Any nominee not being selected to receive the award would have the payment returned to the person nominating that Daughter.

**Clare Haugen #1:** I know the money would be given to the committee, but they need to know that the money goes to the GS. It is on the form.

**Gayle Johnson #18:** If you don't want her to know she being nominated and the Bethel writes a check, she is going to know.

**Diane Ritchie #18:** It is not a requirement that they are not informed.

### **Joanie Peterson, Finance**

Thirteen months ago, at the May 2011 annual meeting of the finance committee, we asked the leadership of the GGC not to focus on the fundraising, but to focus their time, their energy and their resources on developing and strengthening the Bethel Guardian Councils. We have again asked the leadership for 2016-17 the same request.

So what have we specifically done this past year?

1. SnoBall guidelines are in the process of being finalized.
2. Financial question at Bethel 53. After Bethel 53 was closed several Adults wanted to designate how the funds would be distributed. Our law states that once a Bethel is closed, all money and properties revert to the Grand Guardian council.
3. Proceedings 2015. Errors/omissions occurred. A corrected financial report was mailed to those who had purchased a copy of the 2015 proceedings and the web site proceeding was updated. Additionally, the committee recognized two additional issues.

- a. There is a lack of consistency in what data is included in reports. (and our concern is focused on those reports that relate to financial issues). The finance committee is in the process of developing consistent guidelines, to include the name of the event, chairperson of the committee/event, what fiscal year, number of attendees, income, expenditures and more. This is currently a work in progress. There have been reports from past years that some chairman have simply tossed away all data concerning an event.
  - b. We also discovered that a copy of the proceedings were not being mailed to each Bethel each year. An amendment has been submitted to eliminate this requirement. It will continue to be on our web site.
  - c. Lastly, a reminder, it is the responsibility of the (junior) Past Grand Guardian to review the proceedings for accuracy prior to distribution.
4. Camp guidelines have been developed, and reviewed with current camp chairman. The guidelines will be reviewed after Camp 2016 for appropriateness and effectiveness. Items included:
- a. A system to accurately calculate the cost of camp has been developed.
  - b. Have learned that we need to differentiate between full time and part time camper when reporting numbers to Camp Lake Hubert.
  - c. When the Grand Master, Worthy Grand Matron and Worthy Grand Patron attend camp, they are the guests of the GGC and the costs for their meals will be paid for by the GGC.
  - d. We all need to remember that the cost of camp was not \$110.00 (am using 2015 costs for this illustration) but the cost of camp per camper was really \$227.43 (including tax).
  - e. Camp information summary must be passed on from one camp chairman to the next!
  - f. ATV issue: Is yet to be resolved. Last year I realized that an ATV was being used to transport people around camp, in addition to luggage being delivered to the cabins. This has potential for being a liability issue. Camp Lake Hubert insurance does not cover the ATV. Currently, Supreme insurance does not cover the ATVs. We have asked Supreme about the cost of a "rider"/additional insurance to cover the ATV, but have not yet received an answer. We do have confirmation that the owners of the ATVs do have insurance.
5. We do need to note that an error on the May 2015 Secretary's report was just recognized and has come to our knowledge this past week. The then reported investment earnings of \$9,631.15 are actually \$4,631.15. The \$5,000, which carried over to the 2015-2016 year. This will be corrected in the 2016-17 statements.
6. It is the finance committee's responsibility to recommend the mileage reimbursement for the 2016-2017 year. The finance committee does recommend that reimbursement remain at \$0.25 per mile. We have found that now that we are a 501©(3) that most folds simply will deduct mileage on their income tax.

### **Grand Treasurer, M'Lyse Haugen**

Grand Guardian, Associate Grand Guardian, and members of the Grand Guardian Council:

Thank you for the opportunity to serve as Grand Treasurer again this year. I prepared the required financial reports each month and distributed them to the Finance Committee in a timely fashion. Our total Treasury decreased by \$6,223.56 during the past year. The majority of which is due to the investment loss. I also submitted my expense report prior to the Finance Committee meeting. I attended all Executive Meetings of the Grand Guardian Council, the Annual Finance Meeting, and all the statewide events except one.

In addition to my duties as Grand Treasurer I also served as Bethel Guardian for Bethel #1, Grand Bethel Guardian Treasurer, Deputy to Bethel #9, Vice President of the JD Foundation of MN, and Sessions Chairman. If I could use one word to describe this past year it would be overwhelmed. I enjoy each of the roles I have committed to for MNJD, but I just don't enjoy having to do them all at the same time. For my own sanity I have made plans to shift some of these responsibilities to other willing volunteers.

We have done a great job this year focusing on recruiting new members. The next step should be recruiting new adult volunteers. There are so many of us doing multiple jobs in this organization and if we aren't careful we are going to burn ourselves out. With new members should come new adults so next year I hope to see many new faces in this room!

I would like to thank the Finance Committee – Joanie Peterson, Gerry Brandt, and Joy Erickson, along with the Grand Secretary – my mom, for all their help and wisdom over the past year. It has been a pleasure working with you all.

### **Grand Marshal, Sarah Mobroten**

Grand Guardian, Associate Grand Guardian and members of the Grand Guardian Council:

For the 2015-2016 Grand Guardian Council year the following CAV classes were held:

### **Grand Guide, Deb Sigsbee**

Grand Guardian, Associate Grand Guardian and members of the Grand Guardian Council:

The past year has been an eventful one. Prior to Session last year the executive committee decided that the administration of media releases should become a task of the Grand Guide. The transition to this began last summer. A new list was created and is now being shared with the Bethel's regularly. This allows for more frequent updates and gives our councils access to information on other members who may be in their pictures before sharing them. Increasing the access to this list with our councils will also ensure that new Bethel Guardians and Guardian Secretaries will know the importance of keeping media releases on file.

In addition to the media release change I was asked to assist with social media. As a Social Media Policy was desired; I created a policy to outline the items that we often verbally share with others but did not actually have in writing. One example of this is not publishing last names of members on the Internet. This policy will allow us to work towards becoming more consistent as a group with our online practices. With the use of hashtags becoming more mainstream on social media sites I also defined several hashtags to use within Minnesota to allow us to grow our online marketing presence. While doing this some instructional items were added to remedy the issue of items being verbally passed on from year to year but not placed in writing. I became email buddies with the Jurisprudence Committee while completing these items and am grateful for their timely responses and feedback.

## **Supreme Amendments**

**Diane Ritchie #18:** The Strategic Planning committee has restructured the bylaws. If this goes through then we will need to restructure ours also. We need to be working on our problems of getting members, and not be restructuring our bylaws, in my opinion.

### **#7 Addition to Bethel bylaws – Local rules of operation**

Any Bethel may adopt their own rules of operation as long as they don't interfere with the bylaws of the GGC and Supreme – this is just like guidelines.

**Demits – Resignations** – a daughter who has resigned or left for personal reasons, she may petition to become a member. The process is the same as one who has never been a member, the Council will need to check to make sure that her dues were up to date. She will need to be initiated to come back in.

**#12 Organizing a Bethel** – the number needed to start a bethel from 15 to 10 and the council from 9 to 5. That will lower the number needed to start the bethel.

A closed bethel may only be instituted within 100 miles of the original charter.



### **Job's Daughters Foundation**

I am here to invite you each to celebrate with the Job's Daughters Foundation of Minnesota our 20<sup>th</sup> anniversary. It was in 1996 that it was recognized that the Job's Daughters endowment fund (that had been established in mid 1970's) was not meeting the expectations many had for the program. Endowment funds do not provide for tax deductible relief like a foundation could and an endowment fund can never use the principle but only the interest earned. Several folks, including George Miller, Marie Cavers and Jim Billig and others did push to develop a new foundation. We did apply to the IRS for our 501(c)(3) status and it was approved!

We did make the commitment to the founders of the endowment fund to retain their monies in a dedicated fund forever, and we continue to honor that commitment.

By 1997 we had \$900 and we used it to provide each Daughter attending camp, coupons for the camp store. Each girl got 5 or 6 coupons each worth \$1.00. And we thought that we had the world by the tail. For camp 1998 and 1999 we continued to provide the coupons for each Daughters Camper. But over the next years our giving did increase! To summarize the financial giving since that time:

JDF of MN has given a total of \$121,000 to reduce camp registration costs.

Has facilitated an additional \$55,000 gift from the Grand Lodge of MN and via matching funds from MN Masonic Charities \$34,965. For a total financial support of camp registration of \$210,965.

Additionally, the JD Foundation provided a free subscription of the 6<sup>th</sup> Messenger to each Daughter in the state. And while the data is incomplete, this was a donation of well over \$9,000.

Three years ago, the foundation began to support Grand Bethel by assisting with money to reduce the registration costs. To date, the JD Foundation has provided \$9,605 and has facilitated an additional \$9,025 from Masonic Charities via their matching fund program.

But we did not do this by ourselves!

- We are thankful for the 61 lodges, 53 chapters and several Shrine units, Scottish Rite and Grottos who have made contributions to the foundation. **THEY HAVE MADE A DIFFERENCE.**
- We are thankful for all the individual folks who have sent contributions. **YOU HAVE MADE A DIFFERENCE!**
- We are especially grateful for the individuals, lodges and chapters who made the decision to join the Century Club. The Century Club was established in 1999 with the motto:

If a 100 could give a 100, think what we could do.....

They have a full core of Officers and are very active in their community. One of the biggest highlights for the Deputy was her visit when they donated \$2,500 to HIKE from their annual dance. They also donate to one of the High School Theater Departments as some of the girls are involved in theater there. They continue to send packages to the troops and also have donated to the MN Masonic Charities. They have initiated at least 3 new Daughters. The Deputy has been very instrumental in helping the Officers with their floor and Ritual work by doing a start and stop meeting and also helping the adults on the Council with any questions. Their Honored Queen theme this year was Literature.

#### Bethel 11, St. Cloud (re-organization)

The Daughters and the adults are trying very hard to keep this Bethel going! The members in this Bethel are very willing to travel and to help and assist any Bethel that needs Officers. Daughters and adults attended the Paint your Plate in Edina and helped with stuffing stocking for the Shriners Children's Hospital. Helping out at the Food Shelf. The Daughters also participated in the Installation for Grand Lodge.

#### Bethel 16, St. Paul (re-organization)

They also are trying to retain membership. They work well with the DeMolay and have their joint Installations each term! They have dances and other events together. The daughter's continue to have fundraiser, doing a baked potato and chili fundraiser and a Thanksgiving potluck. They willing to attend other Bethel meeting and are will to step in and help out where needed. They have dual members, but I would think it would be hard for Daughters to keep activate at both Bethel's. They also participated in the Grand Lodge Installation.

#### Bethel 17, Owatonna

They have a total of 9 members. They participated in the Grand Guardian's service project at the Shriner's Children's Hospital stuffing stocking for the patients and there siblings. For their Librarian's report a Cello Solo was done by one of their newest members. The Daughters performed the "Living Cross" at the Honored Queen's church and she was also asked to speak about our Organization. The Daughters have friendship, prospect events. They look forward to the Sweetheart Formal with the DeMolay and they are looking forward to JD Camp this year.

#### Bethel 19, Monticello (re-organization)

They are struggling for membership and retention and also need more adult help. Some meetings they might have 5 members other times 3. They help out Bethel's 48, 39 and 1 with initiation's or just help to fill an Office for regular meetings. They also participated in the Grand Lodge Installation. They help out a Sharing and Caring Hands and also collect for Childhood Hunger. Another fundraiser is at Pizza Ranch. They have prospect parties but no one shows up.

#### Bethel 28, Duluth

Did not receive a deputy report for either term. I did have the chance to visit their Bethel twice. Once for a regular meeting and the other for Installation. The Bethel is very active with prospect parties. I attended a meeting last fall and was presented with about 50-60 lb's of pop tabs for the Shriners Children's Hospital. I was also honored to see the performance of the Jobie Hallelujah song. I was in the balcony and it was breath taking. The DeMolay planned their Winterfest in conjunction with Bethel 28's Installation in January. The DeMolay had their Installation in the morning and the Daughters joined them for tubing. The Daughters Installation was that evening and they were excited to have their installation in the Red room. Also, our Daughter HIKE coordinators are from Bethel 28 and are selling charms to help raise money for HIKE. I feel that the adults and daughters work well together.

#### Bethel 32, Moorhead (re-organization)

They help out at the Dorothy Day Food Pantry, delivery Valentine and Mother's Day Flowers and work at the circus.

#### Bethel 39, Robbinsdale

If any of your Bethel Daughters want to go on a road trip's or help out at fundraisers or serve at a pancake breakfast tag along with #39. They help out at the Scottish Rite, Robbinsdale Pancake breakfast and help serve for the Mason's at Arcana. They sell Christmas wreaths, poinsettias and also flowers in the spring. They help out at Initiations and fill in at other Bethels. They participate in almost all the outside activities from the Grand Lodge Installation, to Paint your Plate to serving dinner at the Scottish Rite.

#### Bethel 48, Anoka

This is another Bethel that is growing. They have joint meetings and Initiations with Bethel 1, 19 and 11, and prospect parties and dances with the DeMolay. They have the Jobie-to-be Program and have 3 or 4 prospect's waiting to be initiated. They have gone to

the Masonic Home for their Go to Church, helped out at the Grand Lodge Installation stuffed stocking at the Shriners Children's Hospital and went to Paint your Plate and have tied blankets for the Shriners Hospital. They also have a great Masonic turnout at all their meetings.

**Bethel 76, White Bear (re-organization)**

They are holding their own. The Bethel council is very supportive of the Daughters and will help them in any way. They also need prospects and more adults to help out. They participate in their community and do prospect parties and have friendships. They have bake sales, sell flowers in the spring and sell Papa Murphy cards. At the Deputy's last visit, she watched as one of the new members took her Proficiency. She did an admirable job and should be an example for each of the younger members to follow.

**Bethel 85, Savage (re-organization)**

The Bethel is very active and has many new young and enthusiastic Daughters'. The Joie-to-Be program is going great! The adults have been work with the prospects on learning the songs, doing the floor work and having fun at the same time. The adults are very active in the Bethel and are working hard to see it succeed. Kudos goes to the Guardian Secretary for having all the financial books laid out for the Deputy to look at and all books were up to date.

**Bethel 88, Farmington**

They almost have a full core of officers (-2) stations. They have prospect parties and make sure that each new prospect is emailed an invitation to the Bethel activities. They sell Heggies Pizza's as a fundraiser and will be having another mystery bus trip. I found out last years was a blast. Hope for an invite this year. The Jobie-to-Bee program is still in it infancy, but the adults and daughters are working to get it going. They have an open communications with the Lodge. Not updating the Supreme Constitution and By-Laws books

**D Hennebry #32:** Are the Irregularities supposed to be items from the Ritual, Constitution and Bylaws and the Book of Ceremonies? So one of the things was learning words to Forward All Job's Daughters, they have the option to learn both. That would not be an irregularity. I have been asked to address Signing during the meeting, it is not a irregularity. It is a form of communication that the deaf community and interpreters use. That would not be an irregularity. It does not say that they cannot communicate during a meeting. I do believe that the girls should not be signing during the meeting, just like talking. I was asked to talk about using the proper sign, I was told that if you do not use the proper sign you fingerspell the word and the deaf community would give you the sign. We, Thera and I would be more than willing to teach the girls the songs. Communications, does it say that the communications have to be in paper form? No it does not say that they have to be in paper form. There are circumstances that we may need to read the communications of the phone.

**Beth Bohlmann #32:** The irregularities seem to be the same, the IO not going to altar for obligation, the IO may give the obligation from either the East or Altar. Not sure if this was read, but during Installation not having Installing Officers from your Bethel. They should be asked first. The Bethel's are allowed to have 1 PHQ from another Bethel, not the entire Installation Team.

**Rosemary Guntzel #39:** I see that the girls are communicating during with other during the meetings, through sign language. I don't want to see the girls signing about another girl and she sees it.

**Thera Wiersma #60:** If it is their form of communication fine, but I do agree that they should not be signing during the meeting. This report should be sent to the BG and should be read so the girls can hear it. We are hoping that the girls are using the appropriate signs for the songs.

**Rosemary Guntzel #39:** This is the hardest report to write. I am saying bad things about your Bethel's. These things are happening year after year.

**Sue Jones #39:** When we have daughters signing during nearer my god to thee is there a proper place for them to stand and making sure their signs are accurate. They are signing from the sidelines, I have asked them to stand in the East. I have seen 3 different versions of the song.

**D Hennebry #32:** It does say in the Ritual that you do the attitude of prayer and singing, but.... They may be released from doing the attitude of prayer and sign with permission from the Exec BGC. As an interpreter they would know where they would need to stand. I have stood at the podium and off to the side to interpret. It is the best line of sight for the deaf person. I prefer to be standing. In the closing formation they can be kneeling and signing. Any of the girls can be signing as long as they are giving permission by the Exec BGC. I am a firm believer about those singing the song Nearer My God to Thee must be members or MM. I do not feel that those who were not in Job's Daughters sing that song. In MN we have adopted that the 1<sup>st</sup> verse singing will be by those members in the closing formation and then the 2<sup>nd</sup> verse is sung by all members and MM. In the Ritual it says that the daughters sing the first verse and the second verse all Daughters join in. If a daughter or MM that is signing the song, that is allowed, if they are given permission from the Exec BGC. That is an irregularity that should be in the report, that men and non MM are signing Nearer My God to Thee. It was an honor to be in Job's Daughters. I understand that you were not given the chance, I understand that but...

**Beth Bohlmann #32:** With the approval of the BGC any song may be signed.

### **Associate Grand Guardian, Ken Carroll**

This has become evident when we see adults dropping their CAV certification or not applying to renew or get them in the first place. No matter whether you like it or dislike it, CAV is here to stay. It educates the adults in ways of protecting our daughters. We own it; let's embrace it and move on.

The lack of young adults getting involved with today's youth is becoming more and more prevalent and is a sad indictment on what the future holds for our society in general. There are those hardy souls who are willing to get in the trenches and/or stay in the trenches, but we must convince those other parents that their participation is an essential element in providing the values of our Order to our girls. Perhaps while we are recruiting the girls, we should also be trying to attract the parents. We do have a good product to sell. In speaking to these young adults, those who have been through Job's and are now out in the working world and holding down those nice jobs, we hear them say they owe a part of their confidence and poise to the lessons they learned in Job's Daughters. I am not talking about the "Job's" lessons, but the skills learned by being an officer, planning and executing the activities of her term.

The two young ladies representing Job's Daughters, Miss Minnesota Job's Daughters Marilyn Benn and Grand Bethel Honored Queen Kori Hennebry, could not have been better choices. They fulfilled every duty expected of them and then some. I cannot tell you how proud Rosie and I were, and how proud you should be of what these two young ladies did for the image of Job's Daughters, truly exemplifying what Job's Daughters is all about. Our heart-felt thanks to both of them. I would also like to extend a very special thanks to Jackie Benn as well as D and Mike Hennebry for the time and effort you put in to make sure our daughters were able to fulfill their obligations. Thank you so much.

Rosemary and I decided in our planning that our energy would be directed toward increasing our membership. Our goal was augmented by new rules governing how we can obtain our members.

We have a new prerequisite for soliciting members from other than “Masonic-related” persons and need to take every opportunity to do so. We should encourage our Jobies to ask their friends and class mates to consider joining.

Jobie-to-Bee is another avenue to be utilized - getting the girls younger, before they get too involved in school or community activities. One of our Bethels (Mankato) has worked out a plan with the schools to leave one night a week open for other than school activities. The interests of both the girls and the parents are expanded with a diversified richness in their lives.

Membership throughout the Masonic family, from the Grand Lodge down was utmost in our minds. Grand Lodge offered membership idea meetings to share ways to increase our numbers. Job’s Daughters participated by being represented in each meeting. Interestingly enough, adults like young people are curious about what we do and what we are all about.

Some conclusions of the meetings were:

- o We need to make ourselves more visible to the public with the use of electronic media.
- o Keep our websites updated and on the cutting edge.
- o Community involvement (booths at county fairs)
- o Local newspapers and newsletters (Advertise)
- o Invite people to our Lodge/Bethel (Open House)
- o Do a mock meeting.
- o Talk about things we do, etc.
- o Sell the product.
- o Everyone takes something home to remind them they were there
- o Have a fun event (barbeque)
- o Lastly, ask if they are interested.

It would appear that Job’s is already leading this race.

Armed with our newly appointed Publicity/Marketing Committee, we did exactly what we should – stand back and let new ideas develop. New attractive, easy to set up, display boards were fashioned and offered to each Bethel.

Let’s talk about our Job’s Daughters Jamboree. Okay:

- We showed off our Bethels to non-members (check)
- We held mock meetings (check)
- We took a dance class (check)
- We offered prizes; everyone took something home to remind them they were there (check)
- We went swimming, ice skating and sang to karaoke at the all-nighter (check)
- We GOT NEW MEMBERS. (check)

Everything went off, smooth as silk; no glitches, just like it was planned. NOT. But it was a great time. The Lodge Brothers were there in the morning to provide a breakfast for the girls. We learned a lot and the next one will be even better. Great job, Marketing Committee!

Some highlights this year were Grand Guardian Council Grand Session, camp (always a blast), Grand York Rite Session, DeMolay Jam at St. Peter, Amaranth, Camp, Shrine Circus, Jobie Jamboree, (did I mention camp?), JDU, Tantalizing Table at the Scottish Rite, Grand Bethel, Grand Lodge, Grand Chapter of Eastern Star, (Oh yeah, camp), and Memorial Day at Acacia Cemetery.

At Grand Bethel we elected a new group of Grand Officers lead by our new Grand Bethel Honored Queen Emily Robinson. Also chosen at Grand Bethel were Miss Minnesota Job’s Daughters Francesea DiMatteo (Frannie) and Junior Miss Minnesota Job’s Daughters Kylee Wiersma. Now, the GBHQ and Miss MNJD were instructed in their duties, the first of which would be to deliver a speech to a large group of Masons at the Grand Lodge; and by-the-way, they had all of 4 days to prepare. Both Daughters **KNOCKED THEIR SOX OFF!**

I must touch on Grand Lodge. We opened Grand Lodge with 16 girls from Bethel 28 Duluth who sang “Jobies Halleluiah” and received a standing ovation from 400 to 500 Masonic Brethren. They were further impressed with 53 members of Jobs Daughters doing a living triangle to close their Session.

We have seen Lodges and Bethels decline and then do a complete turnaround to become healthy and viable again. We must continue to encourage the opening and/or reopening of Bethels.

Memorial Day at Acacia Cemetery was heart-warming with many Masonic bodies paying tribute. What was outstanding were the numbers of youth (33 Job’s Daughters and approximately 30 DeMolay boys) that performed their tasks in the ceremonies. The adults, in particular the older adults, were very impressed that the young people took time out to pay their respects to our fallen veterans. And, by the way, our Jobies were fantastic.

One of the plans on the drawing board pertains to a changed Publicity/Marketing Committee, not limited to only three members, but expanded to several members. This should be a committee that enthusiastic people WANT to be on - people who can implement new reasoning, new concepts, new ideas and new methods. And because it is creating the action, it is THE committee to be on. We do not want to change our product, just the way we present it. We do not want to change who we are, just how we do business.

I know Rosemary will agree with me and extend a very grateful thanks to our Finance Committee for believing in the importance of our Marketing Committee and supporting their creative enterprise.

I do digress; let me get back to the Theme “Second time around”. For the most part it was easier, at least the mechanics of what to do. Initiating some new and fresh ideas, I believe we had a successful year with the help of new blood, and at least a look at a new way of doing business.

### **Education Fund, Angela Smith**

This Session of the Grand Guardian Council of Minnesota of the International Order of Job's Daughters will follow Robert's Rules of Order Revised for the deliberation of business. The Grand Guardian will be the Presiding Officer during the business meetings and

may allow any qualified officer to preside. Only those recognized by the Presiding Officer will be allowed to speak.

The Grand Guardian may:

- Impose a fine on an attendee who has a cell phone turned on and interrupts these proceedings,
- Limit discussion on any item of business,
- Limit recognition during discussion, and
- Change the order of business as may be beneficial to the proceedings.

All members of this Grand Guardian Council, as provided in the Manual of Rules and Regulations, who have duly registered, received voting cards, and are present at the Session, shall have the privilege of taking part in discussion and voting.

Robert's Rules of Order shall govern This business session of the Grand Guardian Council of Minnesota in all applicable cases where those rules are consistent with the Constitution and Bylaws of Job's Daughters International and the Manual of Rules and Regulations of the Grand Guardian Council of Minnesota.

All main motions shall be in writing, signed by the movers, and placed on the Grand Secretary's desk for consideration.

Any delegate wishing to address the Grand Guardian Council shall rise, step to the nearest microphone, address the Presiding Officer, and after being recognized by the Presiding Officer, shall state their name, title, and Bethel number before continuing.

Unless special permission is granted by the majority vote of the Grand Guardian Council, no member shall speak longer than (3) three minutes at any one time, nor shall any member speak a second time unless asked to do so.

The maker of a motion or proposer of an amendment shall have the right to speak first on such motion or amendment. Debate on motions or amendments on the floor shall alternate between those "for" and those "against" when there are two sides that desire to be heard.

Any ruling of the Presiding Officer shall be final subject to the Law of Appeal.

I would like your indulgence to clarify "Calling the Question". If a delegate calls out "Question", it is only an informal expression of that delegate's desire to vote on the issue being considered. A delegate may formally ask to end debate only by "Moving the Previous Question". This motion, to be recognized, must have a second, may not be debated or amended, and requires a two-thirds (2/3's) majority to pass. If it passes, the subject motion is voted upon. If, "Call for the Questions" does not pass, debate continues.

Grand Guardian Rosemary, and Associate Grand Guardian Ken, I thank you for your devotion to the Daughters of the Bethels participating in Job's Daughters International in Minnesota. It is observed that you have been living up to the vows you have obligated yourselves to. The Daughters and the adults of Minnesota's Bethel's thank you. Have a wonderful session.

## **Ways and Means**

### **Mary Lynn Montgomery**

It was a pleasure to serve as chairperson for Ways and Means during the 2015-16 Grand Guardian Council year at the request of Rosemary Guntzel, Grand Guardian. I have enjoyed serving the Grand Guardian Council in this capacity, and it was beneficial to serve on this committee for many years.

Sales were conducted at camp, Tantalizing Tables, Grand Bethel, and Grand Session. We sold \$91 of merchandise at camp, \$110 at Tantalizing Tables (all from neck wallets), and \$128 at Grand Bethel, for a total of \$329. This year we added neck wallets and notebook sets, which are selling well. As we want members to purchase and use these new items, we set the price point at \$5 each for neck wallets and notebooks. We continue to have many items that have been for sale for 5—10 years, though we usually sell some of those at events as well as new items. Clothing continues to be popular option with our members, as daughters often ask about t-shirts. We planned to have t-shirts to sell at Grand Bethel, but complications with the artwork meant that they would not arrive in time for the event. In the future, it will be important to clarify the file type Doc Morgan needs for this type of order: vector file with outlined fonts (file extensions are .ai, .eps, .pdf, or .cdr); if these are not available, a 300 dpi file format .psd, .jpg, or .tiff may work. We also ordered both the neck wallets and notebooks from Doc Morgan, as the price they quoted was cheaper than we had found elsewhere. Working with Doc Morgan also greatly facilitated the request for copyright permission.

Doc Morgan items were sold at Grand Bethel for the sixth year. Sales totaled \$398.18 (including sales tax), which is an increase of almost \$150 over last year. Doc Morgan sales have been profitable for the Grand Guardian Council, though not as much as I would like. Sales were strong the first year, but have been lower since then. The cost of return postage and insurance often approaches or even surpasses the profit that we make from these sales. Beth Brown (#48) donated the cost of shipping this year and I have donated it in the past. The benefits of having Doc Morgan items available for sale at Grand Bethel might be something to look at in the future. Many people have enjoyed having these items available in Minnesota, but it may not be profitable or cost effective to continue to place a consignment order.

A special thank you goes to Beth Brown (#48), who has gone above and beyond as a member of this committee. She willingly took on many responsibilities, including selling items at the events, when my graduate school commitments and responsibilities meant that I was not able to do so. It has been a pleasure working with Beth on this committee the last several years.

I have enjoyed working with ways and means the last six years. It has been a pleasure to serve the Grand Guardian Council in this capacity.
